#### SECTION 2: COMPOSITION AND INGREDIENT INFORMATION

Viscose wet wipe. The wipes consists of 70 grams/m2 bio-viscose non-woven material. The lotion in the wipes is a mixture of diverse liquids:

- 95 100% pure water, < 10 ppm
- 0 3% Disinfectant
- 0 1% Natural fragrance
- 0 1% Decyl Glucoside
- 1% Preservative (based on Sodium Benzoate and Potassium Sorbate)

The disinfectant consists of 43 - 47% Citrus Grandis Extract, 33 - 37% Glycerin, 14 -18% Ascorbic Acid and about 3% of Glucose.

The natural fragrance consists of 50 - 100% of Ethanol (CAS 64-17-5) and perfume parts. The actual percentage of ethanol in the end product is between 0.35 and 0.70%.
