4.2 Most Important symptoms and effects, both acute and delayed: May cause mild eye irritation. Prolonged skin contact may cause irritation. The product contains small amounts of a sensitizer, may cause dermatitis in sensitive individuals. Inhalation of vapours or mists may cause respiratory irritation. Swallowing may cause gastrointestinal irritation, nausea, vomiting and diarrhoea.

4.3 Indication of any immediate medical attention and special treatment needed: As a general rule, and in all cases of doubt or when symptoms persist, always seek medical attention. Never give anything by mouth to an unconscious person.

7.3 Specific end use(s): The product is to be used as an engine oil. Prolonged contact with the skin should be prevented due to the risk of skin dryness and cracking. If inhalation of high concentrations of vapours and mists cannot be prevented appropriate personal protective equipment should be used.

8.2 Exposure Controls:

Appropriate Engineering Controls: Use with adequate local exhaust ventilation to minimise exposure. Use explosion proof equipment where required.

Eye Contact: May cause mild irritation.

12.2 Persistence and Degradability

Zinc Alkyldithiophosphate is not readily degradable (1.5 %, 28 d, OECD TG 301 B).

Synthetic base oils are inherently biodegradable.

Trimethylolpropane tricaprilate/tricaprate: no information available.

12.3 Bioaccumulative Potential

Zinc Alkyldithiophosphate has a log Kow of < 3 which does not suggest a potential for bioaccumulation.

Synthetic base oils are not expected to bioaccumulate.

Trimethylolpropane tricaprilate/tricaprate have a log Kow of > 5 which suggests a potential for bioaccumulation.

12.4 Mobility in Soil
